**Notes:**

- The above standalone unaudited financial results of the Company for the quarter and nine months ended 31st December 2023 have been reviewed by the Audit committee of the Board and approved by the Board of Directors at its meeting held on 02/02/2024. The same have been reviewed by the Statutory Auditors who have issued an unqualified conclusion report.
- The Unaudited financial results have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard (Ind AS) prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder and other accounting principles generally accepted in India, as applicable and guidelines issued by the Securities and Exchange Board of India (SEBI).
- The Company operates in single segment only, i.e., chemical and pharmaceuticals; therefore, disclosure requirement of Indian Accounting Standard (Ind AS-108) 'Segment Reporting' is not applicable.
- During the period, the company has complied with circular no. 16/02/2023-OS dated 7th June 2023 issued by The Central Board of Indirect taxes and Customs Drawback division for compliance with the pre-imposed condition for payment of IGST and interest thereon for imports made under Advance Authorization on or after 13th October 2017 till 31st January 2024 on IGST exemption have been availed. As per the decision of the company was non-compliant with the pre-imposed conditions as defined in the revised circular no. 16/02/2023-OS dated 7th June 2023 due to which the company was liable to pay Rs. 259.87 lakhs including interest. The Company has claimed the credit of IGST paid and the interest portion amounting to Rs. 115.65 lakhs has been shown under Exceptional Items.
- The financial results of the previous quarter / year have been regrouped, restated and reclassified to make them comparable wherever necessary.
- The above is an extract of the detailed format of financial results filed with the Stock Exchange under Regulation 33 of the SEBI (Listing and Other Disclosure Requirements) Regulations, 2015.
